Legal Consultation:

The HOA is currently seeking legal advice concerning the creation of searchable documents and a review of our CCR's.

Open Forum (Security issues):

Cars have been seen hiding behind the concrete wall near the clubhouse. They meet other cars and move on.

Please call crime check if you see anything suspicious. If we want action to be taken there needs to be documentation.

Cars parking at the dead end on 12th are causing the homeowners security lights to turn on.

Al Randall had talked to the sheriff and asked to have patrols in the area. Some had felt they have seen more patrol.

There has been auto vandalism.

Most crimes are crimes of opportunity. (for example shut your garage door, Lock your cars) are just a few. Bob and Ginger have installed an auto garage closure and it works great.

Someone asked if we could stop soliciting in our HOA. The only option is to post a sign on your own home.

There had been some young man knocking on doors asking if they had dish or satellite tv.

Another homeowner reported that a man knock on the door and when they answered he walked in and asked to stay for a few days.

Tammy Smith looked into a neighborhood app but there was a monthly fee For Deer Park there is a next door Deer Park app

Suggestion from some were to keep in touch with your neighbors
There has been cars seen cruising around and scoping the neighborhood. Someone asked
if the HOA could purchase cameras for security and placed in the intersections.

More Open Forum:
